- B. Approve minutes of July 7, 2022. Katy made some typo corrections. Mark noted that Debie was left off the attendance. Motion made by Mark to accept the corrected minutes, Patti seconded. 7 yes
- C. Consider approving proposed bylaws, with any desired amendments. Group tweeked the document and voted to approve a recommendation to the Supervisors. A second vote will be taken next month. Patti made a motion to approve the amended bylaws, Katy 2nd. 8 yes (Bruce arrived after the first two action items had been approved.)

Informational/Discussion Items:

A. Discussion Items: Discussed formation of a fire safe council (FSC) for Antelope Valley. Both Mammoth and Swall Meadows have active FSCs. Holly Alpert of the Whitebark Institute talked to the group about how to form a FSC. Some discussion around scarcity of volunteers, who might facilitate (County? Whitebark institute?). Need to include the fire commissioners in the discussion. We requested some kind of "fact sheet" that would outline the benefits of a FSC to try to get more community members involved. Holly volunteered to provide support for the formation of a local FSC.

Supervisor's Report: John Peters shared that there are 13 applicants to fill the vacancy left by Matt Paroullo (Sustainable Recreation Coordinator). Paul Roten is the new Public Works Director. Chris Mokracek has been appointed the Interim Director for Emergency Management. Bodie Rd. is currently closed and under repair by the State. The vacant FEMA parcels in Walker will see some clean up and hazard reduction. The Solid Waste Transfer Station fees are up but the cost for household trash remains at \$5. The second tennis court will get its makeover this summer per the community endorsed plan.

Planning Staff: (Wendy) Serious staffing shortage with Gerry LeFrancois retiring and several planners on part time. Planning continues for cannabis grow at the CA/NV border.
