WHAT IS THE MHSA?

- Voter-approved measure passed in 2004
- Goal of transforming the mental health system
 - Consumer- and family-driven
 - Recovery oriented
 - Accessible
 - Culturally competent
- Report Components
 - Community Planning Process
 - Funding categories
 - PEl Three-Year Evaluation Report
 - Annual Innovative Project Report
 - Updated AB 114 Reversion Expenditure Plan



WHAT IS THE BHAB?

- The mission of the Behavioral Health Advisory Board (BHAB) is to support individuals by promoting recovery, self-determination, and wellness in all aspects of life.
- Advises and evaluates the various functions and policies of the Behavioral Health Department
- Specific required make-up of the BHAB with three-year terms that may be renewed
- Meetings must comply with the Brown Act







KEY ACHIEVEMENTS & OUTCOMES

- Up to 95 people at each Foro Latino
- Approximately 25 Full Service Partnership clients served in FY 2018-2019
- 138 families participated in Peapod Playgroups in FY 2018-2019
- The Walker Wellness Center is seeing approximately 75 visits per month
- The Sierra Wellness Center in Mammoth is seeing approximately 115 visits per month
- Approximately 30 students served weekly in new ESUSD in-class yoga program
- Up to 120 people per month attending monthly socials throughout the County
- MCBH sponsored 12 Community Trainings and is planning multiple Mental Health First Aid trainings
