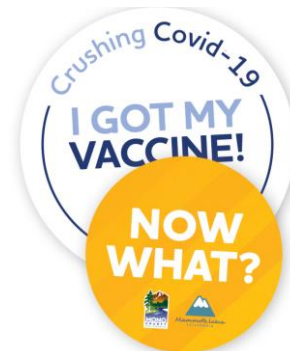




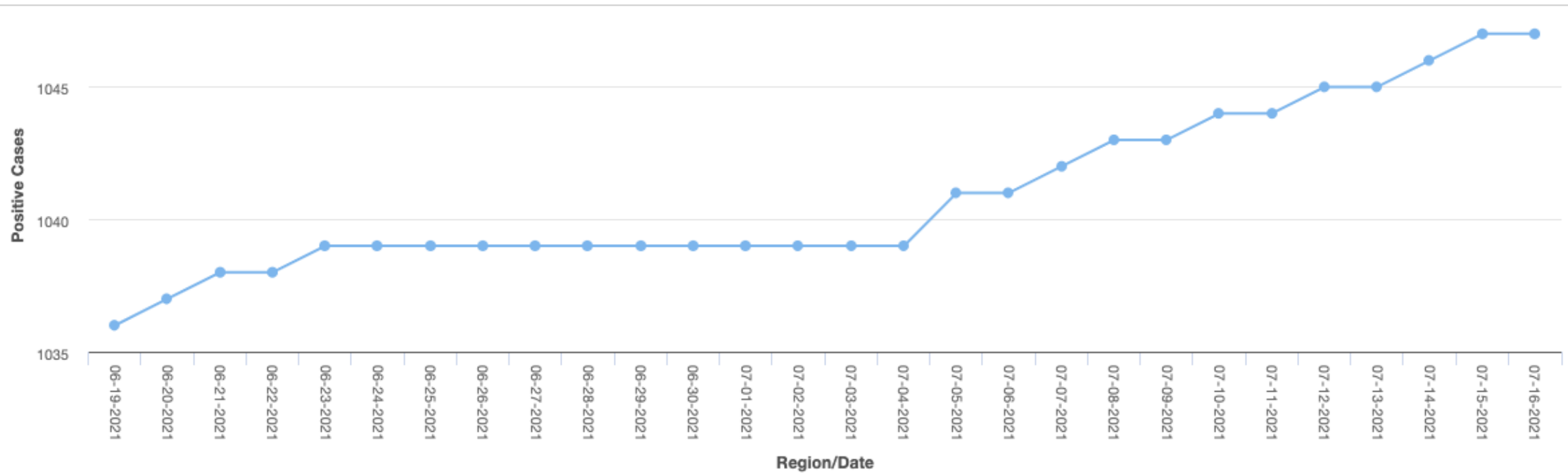

MONO COUNTY PUBLIC HEALTH RECOMMENDS RESUMING INDOOR FACE COVERINGS AS COVID-19 CASES INCREASE

Unvaccinated Residents and Visitors Urged to Schedule Vaccination Appointments

July 19, 2021 – In response to increasing COVID-19 (Coronavirus) cases locally and statewide, Mono County Public Health is recommending the resumption of face coverings for both vaccinated and unvaccinated residents and visitors within indoor public spaces. The added concerns of the Delta variant, as well as a number of “breakthrough” cases (positive COVID-19 cases in fully vaccinated individuals) are cause for concern and could lead to potential rapid virus spread in the Mono County community if not properly mitigated. In addition, unvaccinated residents, and visitors are urged to schedule a vaccination appointment or attend an upcoming Mono County Walk-In Clinic to receive their free vaccination.

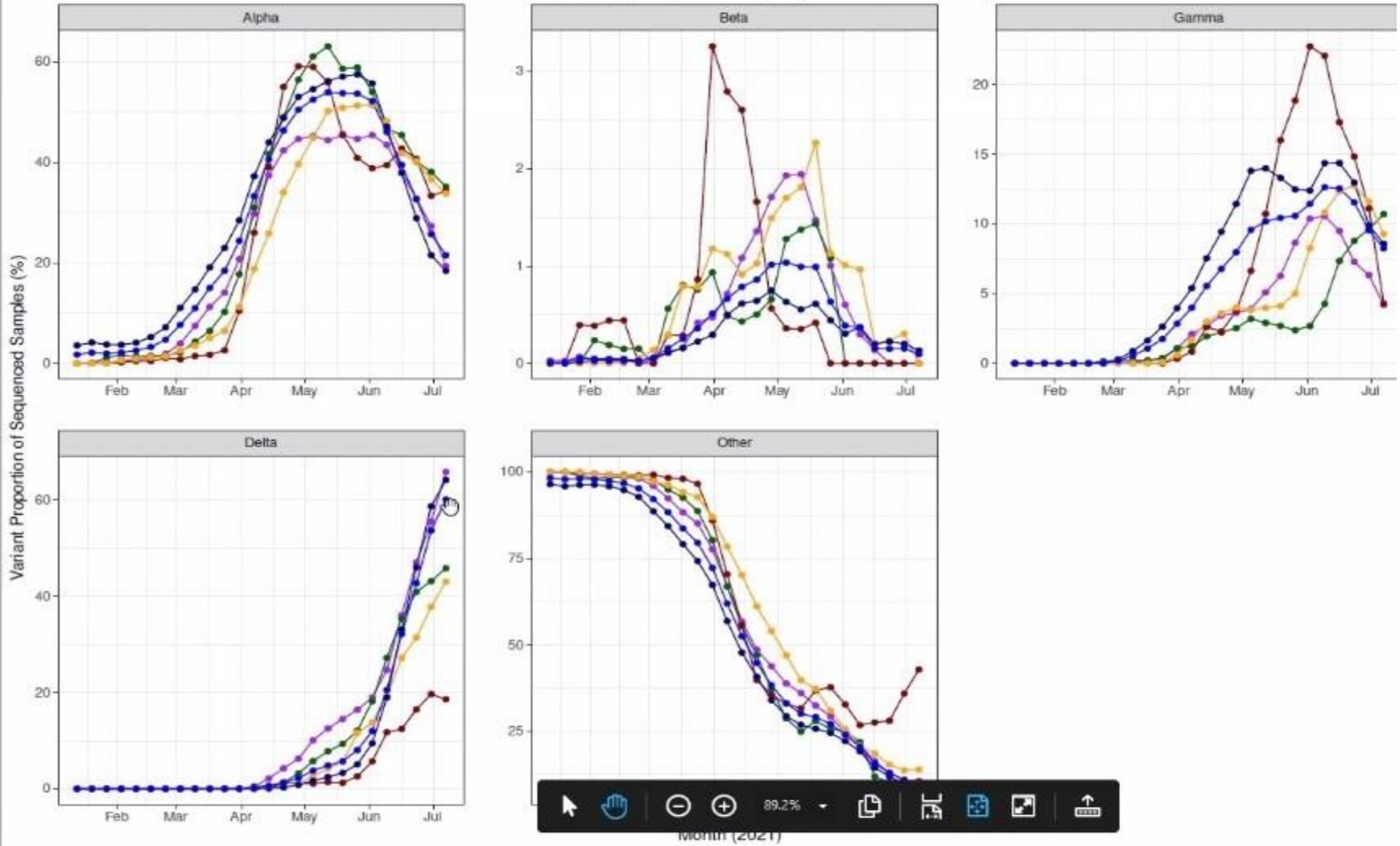


THE DELTA VARIANT

The Delta variant has become the dominant COVID-19 strain, and this has led to a “pandemic of the unvaccinated.” In addition, we have recorded eight breakthrough cases recently...

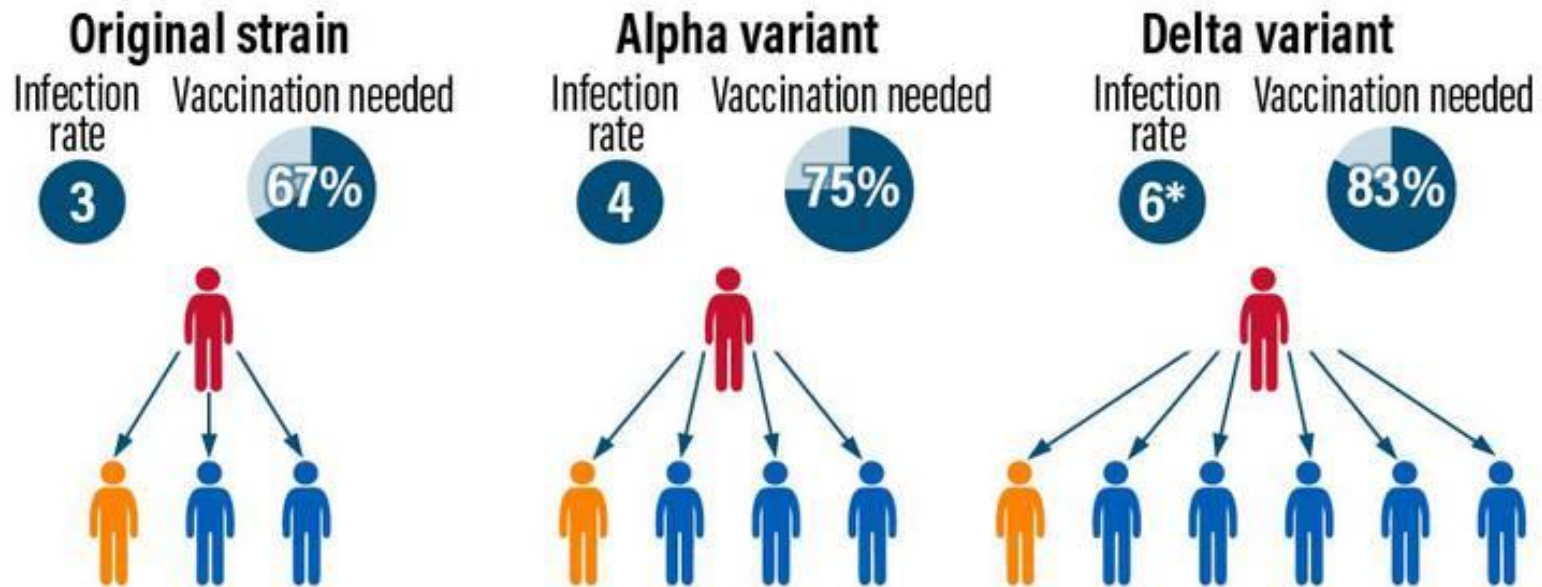
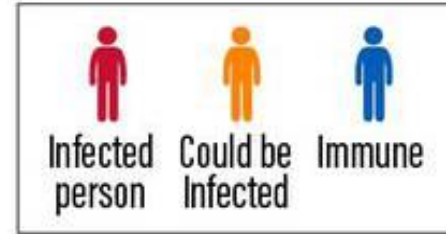
- The Delta variant is particularly concerning for a number of reasons:
 - The COVID-19 vaccines are less effective in preventing infection, with an efficacy rate of 64% - 79%.
 - The Delta variant is more easily transmissible, more infectious, and more virulent.
 - Concerns of a pediatric surge.
 - RO of 6.

HOW DELTA VARIANT AFFECTS HERD IMMUNITY

The Delta variant is more highly infectious than the original strain of Covid-19 or the Alpha variant. This means that the goal of herd immunity is more difficult, as more people must be vaccinated to ensure the virus cannot spread further

COMBATING THE DELTA VARIANT AND VACCINE MISINFORMATION

- Voluntary masking in public spaces
- 350,000 WeVax+ (GovOps) funding for outreach to disproportionately effected populations
- Public information campaign to debunk vaccine misinformation
- Increase the rate of vaccination in Mono County

Post-vaccination COVID-19 Confirmed Cases among Fully Vaccinated individuals – Jan 1, 2021-July 7, 2021



- These cases are identified by matching immunization and confirmed case (PCR) registries
- Post-vaccination cases are defined as cases that occurred in individuals who are fully vaccinated and have a positive SARS-CoV-2 molecular (PCR) test ≥ 14 days after a full vaccination by either two-dose or one-dose vaccine series
 - Missing hospitalization status on about 50% of cases
 - Unclear of hospitalizations or deaths can be attributed to COVID
- Methods continue to undergo validation within CDPH and local health departments
