Antelope Valley RPAC – Led by Gerry Le Francois, a lengthy lively discussion on trails planning in Antelope Valley occurred June 4, with topics including basic trail concepts, current funding opportunities, and the County's commitment to additional outreach on future trails planning. The RPAC authorized letters of appreciation to outgoing members Victoria Victor and Lauretta Cochran, thanking them for their significant commitments. The RPAC also authorized a letter thanking the California Resources Agency for funding improvements at Mountain Gate.

June Lake Citizens Advisory Committee – Following several comments during public comment regarding transient overnight rentals, the CAC scheduled a workshop on the topic for its July meeting. Jil Stark reported on June Lake Trails and encouraged attendance at the June 27 June Lake Trails Day. A workshop on trails will also be scheduled at the August CAC meeting. Supervisor Alpers updated the CAC on BOS matters, and Courtney Weiche concluded review of the June Lake Area Plan.

Mono Basin RPAC – Joe Blommer provided a thorough update on the Lee Vining Rock Fall project (see attachment). Deborah Hess of SCE reported on the status of safety improvements to existing power poles. Margy Verba solicited interest in forming a Mono Basin Fire Safe Council, and Paul McFarland introduced the idea of an RPAC trails committee. Courtney Weiche provided an update on planning matters in the Mono Basin and solicited membership for vacancies on the RPAC, LAFCO and Tourism Commission.

LDTAC – The Land Development Technical Advisory Committee (LDTAC) reviewed and accepted the application for the latest proposal by CSA1 for Crowley Lake Community Center Master Plan for a skate park at the community center. Staff, including Courtney Weiche, Chris Babula, Cedar Barager, Garrett Higerd, Gerry Le Francois and Louis Molina, currently is moving forward on environmental analysis. The LDTAC also accepted Ohanas application to pursue a permanent, year-round food cart near the brewery at June Lake, which Planning Commission will consider July 9.

LAFCO – At the June 3 meeting, LAFCO adopted its annual budget, discussed with Stacey Simon and Brent Calloway an update on hospital service-extension issues and collaboration potential between Mono and Inyo LAFCOs. LAFCO also discussed potential fire district consolidation in the Mono Basin.

Local Transportation Commission – The LTC approved its annual transit allocations for ESTA and YARTS based on detailed information provided by Megan Mahaffey. The LTC approved letters of support for Senate Bills 16 and 321 regarding transportation funding. Deborah Hess of SCE assured the Commission that the proposed trenching along Rock Creek Road has been abandoned. John Helm announced summer transit service to Whitmore Pool, Reds Meadow, and special events. He also discussed additional runs of the Mammoth Express route beginning July 6 (see attachment). The LTC supported proposed truck restrictions on SR 108 (Sonora Pass).

Inyo National Forest wilderness meeting -- Analyst Brent Calloway reported that at its June 9 workshop, the Inyo National Forest (INF) shared results of its analysis of wilderness characteristics and indicated several areas proposed as "potential recommended wilderness," including a large portion of the Glass Mountains in Mono County. Large-format maps were available at the public workshop and are available on the INF website. A decision whether to formally recommend the areas as wilderness will come later this summer with the release of the draft EIR, commencing a 90-day comment period.



Grouse celebration – June 12, Wendy Sugimura and other members of the Local Area Working Group celebrated the recent decision by USFWS to not list the Mono sage grouse as threatened. The celebration at Bridgeport Barns and Terrace was well attended by representatives of multiple agencies responsible for the favorable decision. Big thanks to all partners and agencies in this significant decision for the Mono County region (see attachment).



Information Technology

New Access & Functional Needs application online - Over the past month, Information Technology's Joel Hickok has been working closely with Deb Diaz and the Mono County **Emergency Preparedness Office to** develop a new application to track Access and Functional Needs information for Mono County residents. This database is of critical importance for emergency response and disaster preparedness, as it provides first responders with information about members of our community who require special attention in the event of an emergency or evacuation. The application walks the registrant through a simple five-step process that asks for contact and location



information, then more specifically about what Needs they may have (such as having vision deficit or being oxygen dependent, for example).

Once submitted, the information is secured and managed in a confidential manner by the Emergency Preparedness Office, but can be used in the event of an evacuation, or shared to a first responder upon request. If you, or a family member fits the profile of having an Access or Functional Need, you are encouraged to visit https://gis.mono.ca.gov/apps/afn and register within the application so that our emergency responders are aware of your whereabouts and needs.
