- 1. Delete bid item L-100-6.2: Temporary Airfield Electrical on page BD-4 of the bid schedule. Power to the airfield will be terminate at the existing hangar but power to the hangar will remain on. In addition, no phasing for this project will be required since the airport will be closed. Therefore, there is no temporary airfield electrical service required. Remove the existing page BD-4 and replace it with the attached page BD-4.
- 2. In addition to the requirements as shown on the plans and stated in technical specification L-109, bid item L-109-5.4: Vault Building shall also meet the following requirements:
  - a. Roofs shall comply with the requirements of Chapter 7A and Chapter 15 of the 2007 California Building Code.
  - b. Vents shall not be installed in eaves and cornices.
  - c. Eave and soffits shall meet the requirements of SFM 12-7A-3 or shall be protected by ignition-resistant materials or noncombustible construction on the exposed underside.
  - d. Exterior door assemblies shall:
    - i. Conform to the performance requirements of standard SFM 12-7A-1 or
    - ii. Shall be approved noncombustible construction, or
    - iii. Solid core wood having stiles and rails not less than 1-3/8" thick, or
    - iv. Shall have a fire resistance rating of not less than 20-minutes when tested according to ASTM E 2074.
  - e. Enclosed attics and enclosed rafter spaces formed where ceilings are applied directly to the underside of roof framing members shall have cross ventilation for each separate space by ventilation openings protected against the entrance of rain and snow. Blocking and bridging shall be arranged so as not to interfere with the movements of air. A minimum of 1-inch of airspace shall be provided between the insulation and the roof sheathing.
